

## RATE INCREASE





For the average residential customer using 5,000 gallons per month, this change will result in an increase of approximately \$5.75 per month.

We recognize that rising costs have affected many households in recent years, and the District is no exception. While we have worked diligently to streamline operations and delay rate increases by tightening our budgets wherever possible, we have reached a point where further cuts are no longer enough to sustain the high level of service our customers expect.

Water remains one of the most affordable utilities available, and this rate adjustment is essential to maintaining and improving the system infrastructure that supports reliable water delivery today and for future generations.

## KEEP AN EYE OUT FOR UNAUTHORIZED FIRE HYDRANT USE

Did you know that using or taking water from a fire hydrant without permission is against the law? Unauthorized hydrant use can cause sudden drops in water pressure, damage equipment, and even affect the water quality in nearby homes. It can also mean that water needed for firefighting might not be available when it's most critical.

If you ever notice someone connecting to or using a fire hydrant, please contact the Water District right away to let us know. Try to share details like the location, time and a description of any vehicles or people involved.

Your quick call helps us protect the water system and keep our community safe and prepared in case of an emergency.


## LEAK RESPONSIBILITY

#### District Responsibility

Consolidated Water is responsible for the water line between the meter and the public water distribution main and for the meter (unless the customer tampers with the meter).

### **Customer Responsibility**

All leaks occurring between the meter and the property served are the responsibility of the customer.



Keeping infrastructure up to date and reliable is a part of our commitment to providing quality service to our customers. Capital Improvement Projects help ensure that we maintain enough capacity to meet water needs. Below is a partial list of the Capital Improvement Projects the District has completed in 2025 and what the District has planned for 2026.

2025 Projects Completed	<b>Final Cost</b>
Highway 63 Bore @ Eagle Knoll: Installation of 1,500 feet of 8-inch water main including a 640 feet bore crossing Highway 63 between South Mount Pleasant Road and Westbrook Drive. This project created a redundant feed to the southern portion of the District. <i>Completed Fall 2025</i>	\$300,000.00
Pierpont Area Upgrade Phase 1: Upgrading approximately 7,500 feet of existing waterline with of 6-inch waterline along Tomlin Hill Road. <i>Completed Summer 2025</i>	\$286,000.00

2026 Planned Projects	<b>Estimated Cost</b>
Old No. 7 Upgrade Phase 1: Installation of 5,800 feet of 8-inch water main from Dripping Springs Road North to a point near Silver Fork Creek. Construction estimated to begin Spring 2026	\$360,000.00
Dripping Springs Upgrade Phase 1: Installation of 5,800 feet of 8-inch water main from the intersection of Dripping Springs and Old No. 7 west to Gilbert Road. <i>Construction estimated to begin</i>	\$360,000.00
Pierpont Area Upgrade Phase 2: Installing 4,600 feet of 6-inch water main from Forest Creek Drive south along Tomlin Hill Road	\$170,000.00
