APPLICATION FOR WATER MAIN EXTENSION

TO: Consolidated Public Water Supply District No. 1 of Boone County, Missouri 1500 North Seventh Street Columbia, MO 65201

The undersigned (herein referred to as the "Applicant") does hereby make application to CONSOLIDATED PUBLIC WATER SUPPLY DISTRICT NO.1 OF BOONE COUNTY, MISSOURI (herein referred to as the "District") for extension of the water mains of the District to, at or in the following location:

and Applicant hereby acknowledges and agrees that the following steps will be taken in connection with this application, to-wit:

1. Applicant must meet with the staff of the District to furnish the District with surveys, plats, street plans, sewer plans, storm water plans and other information which will be needed by the District in order to make a determination whether or not to further proceed with the steps needed to make the water main extension.

2. That Applicant must pay all charges of the District's engineer in connection with development of the design, plans and specifications for the water main extension in connection with installing the water main extension and that as soon as the estimated cost of the same has been determined by the District, Applicant will on demand pay to the District the amount of the estimated cost of said engineering work. If the actual amount of said engineering cost exceeds said estimated cost, Applicant will upon completion of the aforesaid engineering work pay the amount of the excess to the District. If the estimated cost of said engineering work is less than the actual cost of said engineering work, the District will upon completion of the aforesaid engineering work is less than the actual cost of said engineering work, the District will upon completion of the aforesaid engineering work refund to Applicant without interest the difference between said estimated engineering costs and said actual engineering cost.

3. Applicant shall furnish to the District engineer all information and documents requested by the District engineer in connection with preparation of the plans and specifications for the water main extension.

4. After the plans and specifications for the water main extension have been prepared by the District engineer and approved by the Department of Natural Resources, Applicant must procure and furnish to the District with the Water Service Contract referred to below herein all waterline easements needed by the District in connection with the water main extension using the waterline easement form of the District.

5. After the plans and specifications for the water main extension have been prepared by the District engineer and approved by the Department of Natural Resources, Applicant must execute and deliver to the District a proposed Water Service Contract prepared by the District in regard to installing the water main extension containing such terms as specified by the District.

After Applicant has executed and delivered to the District the proposed Water Service Contract referred to in the preceding paragraph, the same will be presented to the Board of Directors of the District for review and approval at its next monthly meeting and if said Contract is approved by the Board of Directors of the District the same will then be executed by the President and the Clerk of the District.

7. Applicant must contract with a contractor approved by the District to install the water main extension.

8. The entire cost of the water main extension must be paid by Applicant unless the District agrees to pay for the difference in the cost of pipe for Applicant's project and the cost for larger pipe size required by the District to serve other areas of the District.

9. Applicant must size, locate and construct the water main extension in accordance with the plans and specifications approved by the District and in accordance with the directions of the District which will have the right to inspect the water main extension work as it progresses.

10. Applicant acknowledges that Applicant may be required to extend water mains across Applicant's entire frontage, to Applicants boundary line or to a location specified by the District so that the water mains installed hereunder may be used to serve adjacent properties.

11. After final inspection and testing, Applicant must furnish District with mechanic's lien waivers and transfer ownership of the water main facilities to the District.

12. Applicant shall be financially responsible for a period of one (1) year after District has accepted the aforesaid water main extension work for repair and/or replacement of any defective materials or work furnished in performing the water main extension work and for backfilling work, erosion control work and cleanup work in the area where the water main extension work is performed. To insure that Applicant will perform the foregoing at the time Applicant executes the Water Service Contract referred to above, Applicant must pay to the District a deposit in such amount as determined by the District with the advice of the engineer of the District to insure that the aforesaid work will be done and the District may use said deposit to pay for the aforesaid work. Any unused portion of said deposit shall be returned to Applicant without interest at the end of one (1) year after the date that the District accepts the aforesaid water main extension work. If the cost of the aforesaid work exceeds the amount of the deposit, Applicant shall pay to District on demand the amount of said excess cost.
